Introduction

The month of November marked the first anniversary following the coup that resulted in the ouster of former President Robert Mugabe who ruled the country for 37 years. One year after the end of Mugabe's rule, Zimbabweans continue to suffer from an interlink of socio- economic and political challenges. The economy is in a never ending downward spiral characterized by inflation, acute shortages of foreign currency that have resulted in shortages of fuel, essential drugs and an increase in the cost basic commodities. The US\$8 billion 2019 national budget presented under the theme Austerity for Prosperity failed to resuscitate hopes for a better Zimbabwe. The Minister of Finance, Honourable Mthuli Ncube, increased the duty on petrol by 6.5 cents and diesel by 7 cents which will likely result in further price increases.

November also witnessed the holding of the first National Assembly by-election in Mutoko North and the second Local Authority by- election in Chegutu East after the 30th of July harmonized elections. According to the Zimbabwe Election Support Network (ZESN), in spite of incidents of partisan distribution of food aid, destruction of campaign materials and hate speech during the pre- election period, the two by- elections were held in a peaceful and calm political environment. ZANU-PF won in the two by- elections.

The Commission of Inquiry established in terms of the Commissions of Inquiry Act [Chapter 10:07] to investigate the 1st of August 2018 post- election violence continued with public hearings in Harare. Members of the Zimbabwe National Army (ZNA), Zimbabwe Republic Police (ZRP), CSOs, medical practitioners, vendors, ballistics expert and MDC Alliance leaders, among others, testified before the Commission. The public hearings were concluded on the 27th of November 2018. The Executive Summary of the Commission's report was presented to the President Mnangagwa on the 29th of November. The final report is due by 19th of December 2018.

Summary of Violations

In the period 1 - 30 November 2018, **35** new victims of Organized Violence and Torture were documented from separate incidents that occurred around the country. Some victims suffered multiple violations. ZANU-PF supporters, ZRP and ZNA were equally responsible for the violations perpetrated during the month. The Mutoko North by- elections were characterized by the partisan involvement of traditional leaders in the distribution of food aid. Some village heads were reportedly party agents for ZANU PF in contravention of the Traditional Leaders Act and Section 281 of the Constitution, which clearly states that, "*Traditional leaders must not be members of any political party or further the interest of any political party*".

The table below summarizes cases of OVT for November 2018.

NB: The following notes should be put into consideration when reading these cases:

- Human rights violations contained in this report are derived from statements made to the Forum's Public Interest Unit, its member and partner organisations.
- The identities of victims whose names have not been published in the press and are not public officials are protected. This is done in order to protect the victim from further violence, intimidation and possible reprisals.
- The Report cannot be considered as the exhaustive record of all incidents of politically-motivated violence in Zimbabwe in the period under review. Nevertheless, every incident reported to the Forum directly or through its members is meticulously documented and included in the report.

The perpetrators attempted to abduct one of the security men who blocked them but he jumped out of the car as they attempted to drive off with him. Chamisa had previously taken down number plates of suspicious vehicles tailing him, which were reported at Avondale Police Station as well as Harare Central Police Station. 14 Nov	Politicization of food aid	Justin Mushonga, ZANU PF development Chairperson for ward 11, Chiwundura Constituency, Midlands allegedly told the residents that the community poultry project of 20 000 chicks was sponsored by the Zimbabwe Defence Forces (ZDF) and would only benefit ZANU PF members only. He further told them that they could go and report anywhere they like. He also declared that he would not work with Levyson Chiminya who is the MDC-A Member of Parliament in the constituency. 15 Nov	Assault	The Forum received a report from Ngonidzashe Tinarwo, from Kwekwe who claims to have been bedridden for 3 months after ZANU PF activists assaulted him during elections. 22 Nov	Violation of freedom of the media & assault	Two police officers allegedly assaulted and harassed Nyasha Mukapiko (a freelance Open Parliament journalist) for covering clashes in parliament in Harare before announcement of the national budget by the Finance Minister. 25 Nov	Abduction	Elliot Piki (Retired Lieutenant in the ZNA and former ZANU PF member) was allegedly abducted by suspected State agents as a way of deterring him from testifying in the 01 August Motlanthe Commission hearings. Nature of violations

Violations during the month of November were mostly politicization of food aid, abductions, torture, violation of freedom of the media, arbitrary arrest and detention and harassment and intimidation. The highest number of violations were as a result of politicization of food aid. Food aid was used as a political tool by village heads during the Mutoko North by-elections. The violations are summarized in Figure 1 below.

Figure 1: Violations for November 2018





FIGURE 2: Distribution of Perpetrators by Violator Institution 30 November 2018



ZANU-PF were the main perpetrators of violence, accounting for 54% of the violence, followed by ZRP and suspected State agents, who both accounted for 15% of the violence. The Gweru Municipal police and the ZNA both accounted for 8% of the violations that were documented for the month of November 2018.

Conclusion

Although there is a marked decrease in cases of overt human rights violations, impunity remains entrenched in the politics of Zimbabwe, as perpetrators of violence are rarely made accountable. Victims of violence are often vulnerable as the police arrest them to shield the perpetrators. This behaviour discourages victims from speaking out for fear of reprisals. It is with this in mind that the Forum urges the Government of Zimbabwe to take a stand against the arbitrary deprivation of life; respect the findings of the Montlanthe Commission of Inquiry and bring to account those responsible for the 1st of August 2018 human rights violations.
